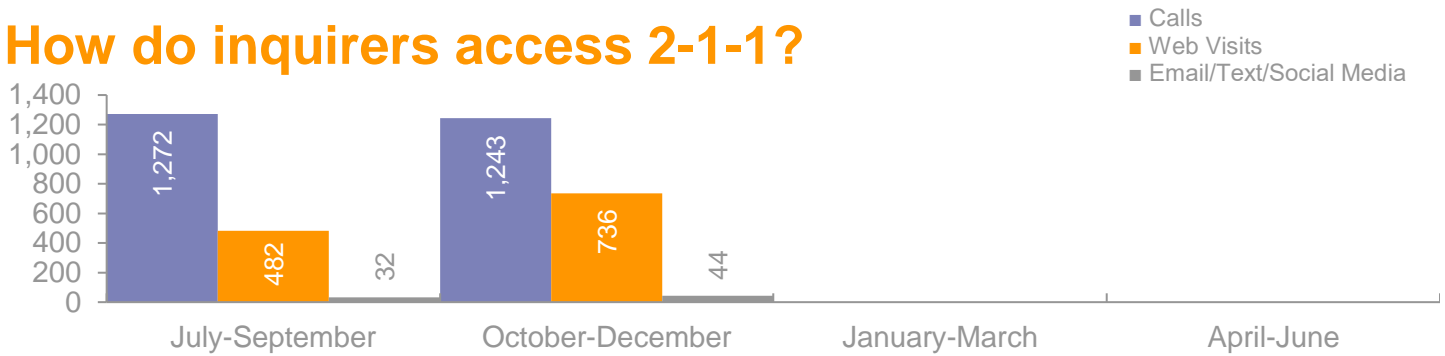

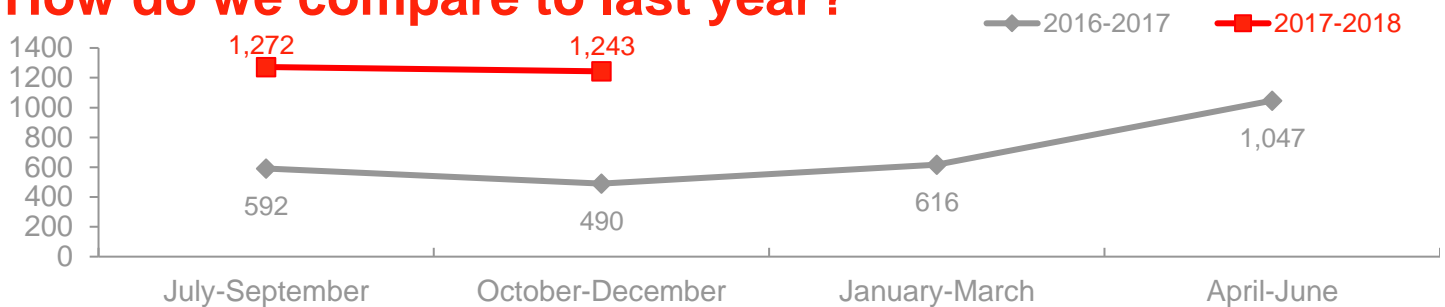

This quarter, 2-1-1 provided resource information **2,023** times to people who visited our website, called, text messaged, utilized our social media platforms, and emailed.

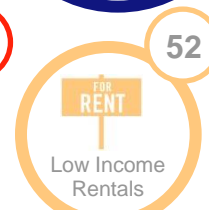
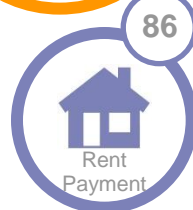
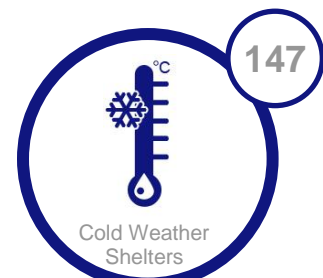
How do we compare to last year?



This quarter, 2-1-1 received **1,243** calls for health and human services. This resulted in a **2%** decrease in calls over last quarter and a **154%** increase over the same quarter last year.

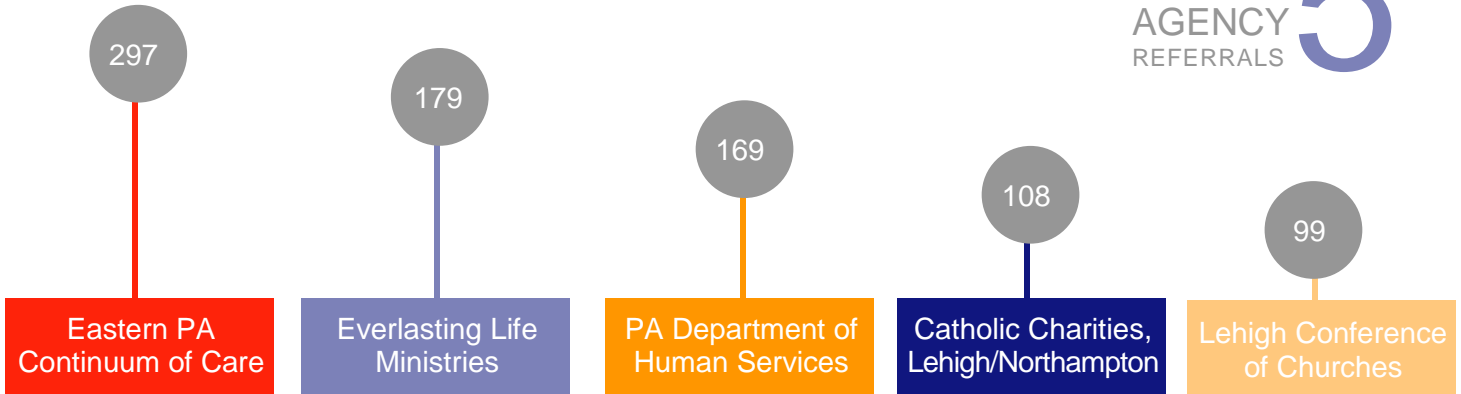

What referrals do inquirers receive?

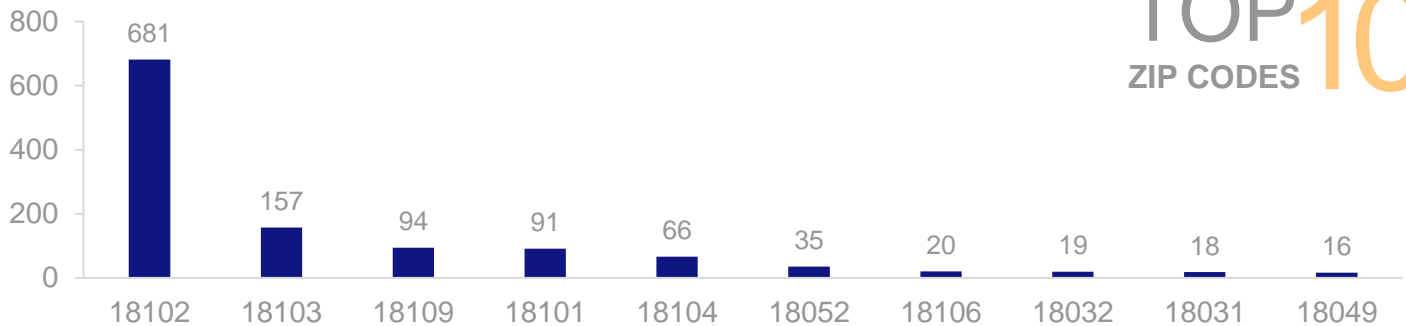
TOP 5

REFERRALS



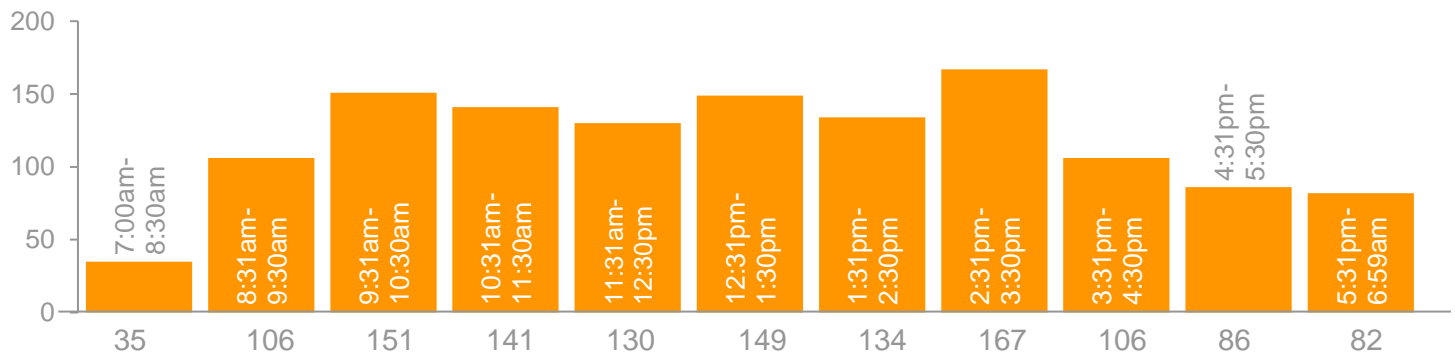
2-1-1 made referrals to **334** programs/services through **206** individual agencies that serve Lehigh County residents.

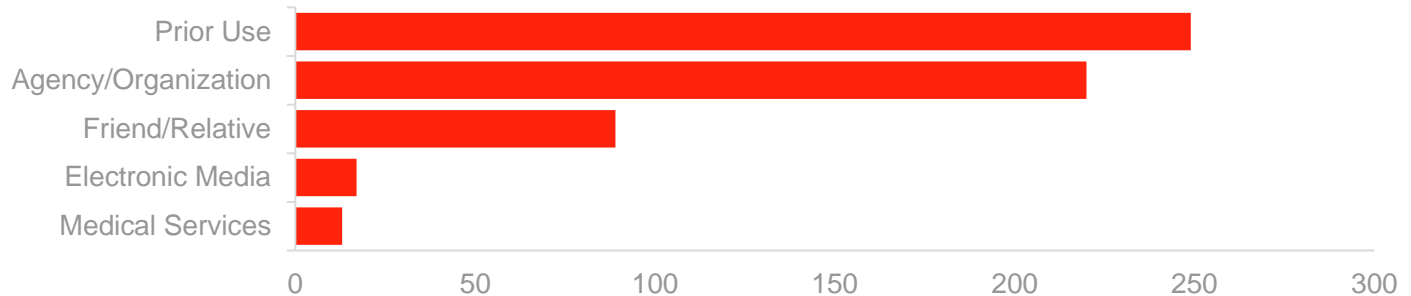

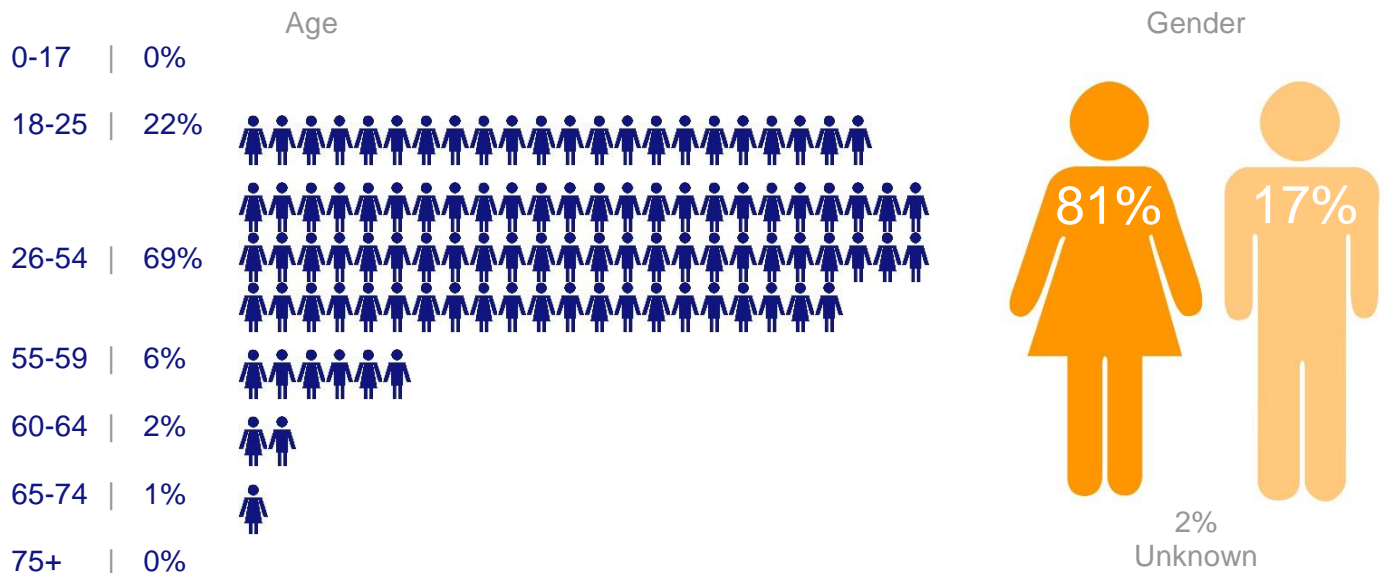

What are potential service gaps?

There are times when a specialist is not able to refer for the inquirer's specific need.

This may occur when the agencies that provide a certain type of assistance are out of funds or when a client is deemed ineligible. When a need is recorded as "unmet", the 2-1-1 specialist explores other resources and services that may be of assistance.

Top unmet needs

Community Shelters/Transitional Housing*	189
Rent Payment Assistance	8
Holiday Gifts/Toys	6
Extreme Cold Weather Shelters	5
Electric Service Payment Assistance	4

*Inquirers are deemed ineligible for shelter referrals when they do not meet the literal homelessness criteria.
